- •Mediated a complex corporate dissolution and debt workout, involving a substantial regional construction company, claims between owners and bond claims.
- •Mediated a multi-party dispute between bar and restaurant owners and lenders involving debt workouts, tort claims, corporate and partnership dissolutions and liquor license compliance.

- •I have also been a long-term officer, director and owner of a family-run business, and director and managing partner of one of Montana's largest law firms.

Construction Disputes:

- •Mediated numerous claims between owners, contractors or suppliers over claims of non-performance of construction contracts, delays, interference and change orders.
- •In a lengthy litigation career, I have represented general contractors, subcontractors, suppliers and design professionals in more than forty separate litigated matters involving construction contract claims, including claims for nonperformance, delays, Miller Act claims, construction liens, improper design or oversight and back-charges.
- •I have served as the owner's representative in the design and construction of four large commercial construction projects and the construction of a large religious building.

Construction Defect Disputes:

- •Mediated two claims involving claims of contractor negligence producing defective construction and resultant damages.
- •As a lawyer, I have represented homeowners of associations asserting construction design defect claims involving over 65 buildings with 105 living units, including claims of defective foundations, improper design for soil conditions, improper roofing, flashing, window installation and other building envelope

defects. I have also defended design professionals against professional negligence claims and, prior to serving as a homeowner attorney, have defended general contractors and subcontractors on claims of negligent construction.

Estate and Business Succession Disputes:

- •Mediated more than a half-dozen disputes between heirs of estates, often with substantial assets and ongoing businesses, which involved claims of testator incompetency or undue influence, improper exercise of authority by one or more heirs, ongoing family business disputes, and the division of businesses or assets. These complex, multi-party mediations required the mediator to facilitate resolution of challenging business and tax matters in the heat of intra-family animosity.
- •As a litigator, I have handled numerous disputes involving Will Contests, claims against personal representatives, claims of undue influence in inter-vivos gifts, claims of trustee misconduct, legal malpractice by estate planners and farm and ranch dissolutions.
- •I have successfully guided several family businesses through planning for succession of control of a family business from one generation to the next.

Insurance:

- •Mediated claims of non-coverage within the mediation of a construction defect dispute, involving application of the business risk exclusions and other terms.
- •As a litigating attorney, I have brought and defended claims for coverage and defense for both insureds and insurers, as well as claims for improper claims handling. Examples include litigation for coverage and defense in construction defect claims, pollution claims and CPA violations. I prosecuted a large case against Lloyds of London and the London Market Insurers for coverage and bad faith, and have been involved in multiple Declaratory Relief actions, including one in Colorado involving allegations of improper claims handling and choice of law. Have also represented individuals in claims against medical insurers for non-payment of benefits or denial of coverage for recommended treatments.
- •I served as a Trustee of the State Bar of Montana Group Benefits Trust, which provided medical and other insurance products to members of the Montana Bar, their employees and families.

Personal Injury:

- •Mediated a significant claim involving life-altering injuries resulting from a collision between a motorcycle and a farm truck.
- •Mediated a claim for injuries arising out of an intersection accident with claimed soft tissue injuries.
